OFFICE ORDER

The "**Basumata Enterprise, Bid Id: 3957130**" Madarat, Atghara, Baruipur, South 24 Parganas, West Bengal has violated norms & rules during competitive bidding and contract implementation by uploading of falsified and fake documents relating to work credential against e-NIT No-WBIW/EE-II/CD/NIT-09e/2023-24, Sl. No.-04, e-Tender Id: 2023_IWD_5589561_4 of the Executive Engineer-II, Canals Division, I&W Directorate.

In accordance with I& W Deptt. No. 03-W/2017-18 dated 18/05/2017 read with corrigendum Memo. No. 10-IB /IW/P/IB/Misc-03/2017-18 dated 06/04/2018, the TEC of the said tender, recommended for debarment from participating into any procurement for "**Basumata Enterprise, Bid Id: 3957130**". As per the above recommendation of the TEC the matter was placed before the Departmental Tender Committee for South Bengal (DTC), I&W Department which upheld the recommendation of the TEC.

Now in compliance with the relevant Govt. Order of the I& W Department and as per recommendation of the Departmental Tender Committee for South Bengal (DTC), I&W Department the bidder "**Basumata Enterprise, Bid Id: 3957130**", Madarat, Atghara, Baruipur, South 24 Parganas, West Bengal is debarred from entering into any procurement system under the Administrative Department of West Bengal for a period of **six month** from Date **24.04.2024** to Date **20.10.2024** and with a direction to **forfeiture of Earnest Money**. This has been concurred by the Deputy Secretary I&W Deptt, Govt. of West Bengal vide Memo No: 177-IB/IW-14011(33)/2/2021[E-376266], Dated. 22.04.2024 .


