




**OFFICE ORDER**

The "**BABA LOKENATH ENTERPRISE**" of Paschim Para, P.O.- Madarat, P.S.- Baruipur, Dist.- South 24 Parganas, PIN- 743610, West Bengal, has violated norms & rules during competitive bidding and contract implementation by uploading of falsified and forged documents relating to work credential against two nos. serial of works in e-NIT No. WBIW/EE-II/JOY/NIT-1(e)/2024-25, Sl. No.- 03 & 12, [e-Tender Id: 2024\_IWD\_714433\_3 & 2024\_IWD\_714433\_12] of the Executive Engineer-II, Joynagar Irrigation Division, I&W Directorate.

In accordance with I&W Deptt. Memorandum No. 03-W/2017-18, dated 18.05.2017 in conjunction with corrigendum Memo. No. 10-IB /IW/P/IB/Misc-03/2017-18, dated 06.04.2018, the concern TEC of the said Tender, recommended for penal action as per instant clauses of the e-NIT against the bidder '**BABA LOKENATH ENTERPRISE**'. In continuation of the above recommendation of the TEC, the matter was placed before the Departmental Tender Committee for South Bengal (DTC), I&W Department, which upheld the recommendation of the TEC.


Now in compliance with the relevant Govt. Order of the I& W Department and as per recommendation of the Departmental Tender Committee for South Bengal (DTC), I&W Department, the bidder "**BABA LOKENATH ENTERPRISE**" of Paschim Para, P.O.- Madarat, P.S.- Baruipur, Dist.- South 24 Parganas, PIN: 743610, West Bengal, is **debarred** from entering into any procurement system under the Administrative Department of the West Bengal for a period of **6 (six) months** for committing 1<sup>st</sup> Degree offence **from date 11.03.2025 to date 06.09.2025** and with a direction to **forfeiture of Earnest Money for both the serials of works**. This has a concurrence by the Deputy Secretary I&W Deptt, Govt. of West Bengal vide his Memo No: 89-IB/IW-14011(33)/2/2021 [E-376266], dated 24.02.2025.
