Office Order

As the Agency named " Sanjib Saha " Raja Rammohan Roy by lane P.O- Rabindra Sarani, Siliguri-6, being the L1 bidder in connection with the work, "Protection work along right bank of river Balason (length 260 m) at Binoy Nagar area within Block & P.S- Matigara, Dist.- Darjeeling." in relation to e- N.I.T No. WBIW/EE/SLGID/NIT-07(e)/2024-25, Sl. No.01 floated on 28.03.2025, e-Tender ID no.2025 IWD 832679 1, was issued LOA by the Executive Engineer, Siliguri Irrigation Division on 19.05.2025 with a direction to submit "Additional Performance Security" in form of "Bank Guarantee" of any scheduled Bank payable at Kolkata/in West Bengal @ 10% of the tendered amount, as the rate quoted is less than 20% of the amount put to tender. But despite of a reminder issued by the Executive Engineer, Siliguri Irrigation Division vide Memo No. 668 dated 27.05.2025, the agency without justifiable cause, have failed to submit "Additional Performance Security" in form of "Bank Guarantee" after 14(Fourteen) days of issuance of LOA. Hence the matter is placed to DTC for final decision. In the meeting held on 27.06.2025 at Jalasampad Bhawan the Departmental Tender Committee (DTC) recommended that the agency has committed offence under clause 9 D (x) & (xiv) of e-NIT which tantamount to offence of First Degree under Clause 9.E (a) of e-NIT inviting the punishment of forfeiture of Earnest Money and debarment for a period 01 (One) year as per clause 9G (b) of e-NIT. In this regard as directed by the Deputy Secretary to the Government of West Bengal, Irrigation and Waterways Department vide his Memo No. 467-IB/IW-14011(33)/2/2021-Sec-IW(E-376266) dated 19.09.2025, the Agency " Sanjib Saha " Raja Rammohan Roy by lane P.O- Rabindra Sarani, Siliguri-6, is hereby debarred to participate in all tenders under the Administrative Department of Government of West Bengal for a period of 1 (One) year with effect from 23.09.2025 and the Earnest Money of the bidder stands forfeited.

The Superintending Engineer, North-East Irrigation Circle-II, I & W Directorate, is hereby instructed to take necessary action to forfeit the Earnest Money deposited by the bidder with immediate effect. This order shall be brought to the notice of all concerned for

strict compliance.
