The bidder "**Rafayel Construction**" has identified as guilty in terms of Clause 11.D.(vi) of e-NIT-WBIW/SE//DIC/NIT-05(e)/2025-26 i.e "due to refusal to accept an award after issuance of 'Letter of Acceptance' or enter into contract with the Government without justifiable causes".

The Chief Engineer (West) has referred the debarment proposal to the Department duly recommended by the Departmental Tender Committee. The DTC has recommended debarment of the bidder for a period of one year and forfeiture of Earnest Money, as a 1st degree offence in terms of Clauses 11.E.(a) & 11.G.(b) of this e-NIT

In view of above, the undersigned is directed to convey the approval of this Department towards DTC recommendations i.e debarment of the bidder for a period of one year and forfeiture of Earnest Money.
