NOTIFICATION

In view of the Teesta Barrage SCADA-PLC automation & up-gradation project having been sanctioned, tendered and is about to commence immediately, and also that the said project is very complex in nature comprising civil work (Remodeling of Monitoring stations, Control Rooms, Painting of structural steel members), hydraulics (Flood forecasting & discharge measurements of river & canals), Mechanical works (all types of barrage gate components), Electrical (Revamping & up-gradation of power supply & distribution network), Electronics (All local control panels & Master control system), Instrumentation (sensors, RTU, data loggers, APCP, transducers, ARG etc), Telecommunication (satellite communication, Radio Frequency, cables, Ethernet, Optical fiber & GSM/GPRS telemetry) subcomponents which is to be executed through Engineering Procurement & Construction contract model, the Government in the Irrigation & Waterways Department has decided to modify the **working jurisdiction of Teesta Barrage Electrical Division** under Teesta Barrage Project, Irrigation & Waterways Directorate in the interest of smooth and efficient delivery of services and performance so that the Executive Engineer and his entire technical team of Assistant Engineers and Junior Engineers are able to perform their duties in an effective manner in accordance with the actual requirement:

- A. Working jurisdiction of Teesta Barrage Electrical Division is now being modified as highlighted below:
1. Electrical maintenance of Teesta Barrage and Head Regulator structures.
 2. Electrical maintenance of Mahananda Barrage and Head Regulator structures.
 3. Electrical works of Dauk Barrage and Head Regulator structures.
 4. Teesta Barrage Remote Control SCADA-PLC Automation projection sanctioned under Core Plan. (two years construction period plus six years 24 x 7 operation of gates, maintenance, training, up-gradation under EPC Contract).
- B. All other works and working jurisdiction presently under Teesta Barrage Electrical Division mainly comprising the following would be immediately transferred to:
- a. Executive Engineer, Teesta Mechanical Division
 - b. Parent Civil Divisions under Teesta Barrage Project.
 - c. Electrical works under Chief Engineer (North East) may be executed by the parent Civil Division on the basis of recommendation of Superintending Engineer, North Bengal Mechanical & Electrical Circle.
1. All new and on-going works under Plan, Non-Plan, Arbitration & Court Cases etc would be suitably re-allotted to Executive Engineer, Teesta Mechanical Division and Superintending Engineer, North Bengal Mechanical & Electrical Circle or the parent Civil Divisions within Teesta Barrage Project which to be decided by the Chief Engineer, Teesta Barrage Project.
 2. It is so arises that certain electricians or operators cannot be replaced immediately, he may be placed on deployment service by Chief Engineer, Teesta Barrage Project.

3. Electrical maintenance of staff colonies & Office campuses at Oodlabari, Gazoldoba, Islampur, Karnojhora, Moynaguri, Haftiagang, Panjipara, Tinbatti, 2nd Mile etc is to be re-assigned suitably by the Chief Engineer, Teesta Barrage Project.
4. In case of pre-monsoon ongoing M/R works under Teesta Barrage Electrical Division, Chief Engineer, Teesta Barrage Project may suitably decide on transferring the balance work to other Division or permit continuation under existing Division so that the purpose of this order is not diluted in any manner.
5. Mechanical & Electrical works, DPR and relevant matter relating to Gazoldoba Tourist Hub (Phase-II) shall continue to be looked after by Teesta Mechanical Division.

This order would be brought into immediate effect.
