- b) To ask the candidate to make a declaration of his/her date of birth in proper form and submit the same together with attested copies of his/her certificate of School Final/Higher Secondary or equivalent examination (one copy each of these documents) direct to Irrigation & Waterways Department and also to the Director of Personnel & Ex-officio Chief Engineer, I&W Dte.
