Sub: Immediate release of 34 (Thirty four) Junior Engineers who have been transferred earlier vide this Deptt's Notification No. 20-IE dated 19/03/18

Sir,

This is to bring your kind notice that the Department had issued a transfer order for 175 (One Seventy Five) Junior Engineers (Civil) vide Notification No. 20-IE dated 19/03/18.

Even after a period of 8 (Eight) months, it has come to the notice of the Department that 34 (Thirty Four) officers have not been released yet from their parent places of posting and have not joined in their new assignments in compliance with the said Notification.

This is a clear violation of Government Order and the Department has taken a serious view for this non-compliance by the Executive Engineers.

Considering the above facts, you are requested to strictly ensure the release of 34 (Thirty Four) Junior Engineers as mentioned in column 2 in the table below by the concerned Executive Engineer latest by 07/12/18.

It is to be further stated that if any officer other than these have not yet been released he/she may also taken into account.

Concerned Superintending Engineers may also be requested to follow up the process with sincere effect.
