ORDER

The Governor is pleased to approve the extension on re-employment of Sri Anish Ghosh, Chief Engineer, I&W Department, in the post of Chief Engineer, I&W Department, for the period of 01(One) year with effect from 01.02.2019 to 31.01.2020, in terms of approval of the Hon'ble Chief Minister, Government of West Bengal.

Last pay as will be drawn by Sri Anish Ghosh is Rs.58, 820/-(including Grade pay) in PB-5, Rs.37400-60000/- with Grade pay of Rs.8, 900/- in the post of Chief Engineer. So, the proposed basic pension before commutation is Rs. 29,410/-

Fixation of pay as well as drawal of pay and allowances for the re-employment period in respect of Sri Anish Ghosh will be finalized in due course in terms of Finance (Audit) Department's Memo No. 3951-F dated 27.05.2009 read with the Memo No. 6961-F dated 15.07.2009. Overdrawal, if any, occurred due to fixation of pay etc. will be recovered from Pay & Allowances of Sri Ghosh for officiating in the post of Chief Engineer.

The Principal Accountant General (A&E), West Bengal is being informed accordingly.


