ORDER

The Governor is pleased to approve the extension on re-employment of Sri Swapan Kumar Pandit, Executive Engineer, I&W Department, in the post of Executive Engineer, I&W Department, for the period of 01(One) year with effect from 01.02.2019 or from the date of his joining the said post or until further order, whichever is earlier, in terms of approval of PAR Department, Government of West Bengal vide their Memo No. 43-PAR dated 15th January, 2019 read with the U.O No.Group-P2/2018-2019/0948 dated 25/01/19 of Finance Department.

Last pay as will be drawn by Sri Swapan Kumar Pandit is Rs.40, 810/- (including Grade pay) in PB-4B, Rs.28,000-52000/- with Grade pay of Rs.7600/- in the post of Executive Engineer. So, the proposed basic pension before commutation is Rs. 20,405/-

Fixation of pay as well as drawal of pay and allowances for the re-employment period in respect of Sri Swapan Kumar Pandit will be finalized in due course in terms of Finance (Audit) Department's Memo No. 3951-F dated 27.05.2009 read with the Memo No. 6961-F dated 15.07.2009.
