MEMORANDUM

In continuation of this Department's Memorandum No. 32-IB dated 08.05.2015 and its subsequent corrigendum vide Memorandum No- 69-IB dated 08.06.2015, issued in connection with the sanction of hired vehicles under the Department with the concurrence of Finance Department, conveyed vide their U.O.No. **Group-T/2015-2016/0052 dated 01.04.2015**, after careful consideration of the matter regarding monthly expenditure of hired vehicle, partial modification of CI No. 7 of this Department's Memorandum No. 32-IB dated 08.05.2015 is made as follows.

1. The monthly total expenditure for each hired vehicle or motor driven boat shall be limited to Rs. 40,000.00 (Forty Thousand) only, inclusive of all i.e. hiring charges, fuel consumption, mobile oil, over-time and parking fee as applicable.
2. The monthly total expenditure of each hired launch shall be limited to Rs. 1,50,000.00 (One Lakh Fifty Thousand) only, inclusive of all i.e. hiring charges, fuel consumption, mobile oil, over-time and any other charges as applicable.

All other terms & conditions, of the above stated two orders stand valid.


