ADDENDUM TO MEMORANDUM OF DSRP CONSTITUTION

Irrigation & Waterways Department is participating in the World Bank funded State Sector Scheme of the Central Government namely, Dam Rehabilitation and Improvement Project (DRIP), Phase-II with a view to rehabilitate 3 major dams and its appurtenant structures and 13 barrages across the State.

2. As per the guideline of DRIP (Guidelines for safety Inspection of Dams, January-2018) circulated by Central Water Commission, formation of a Dam Safety Review Panel (DSRP) by each State Government is mandatory to firm up the preliminary proposals submitted under DRIP through dam inspection and conducting required studies. Any rehabilitation work proposal to be undertaken by a Dam Owner must include the recommendations of DSRP.

3. In view of above, a 7-member Dam Safety Review Panel (DSRP) was constituted vide this Department's memorandum No.180-I/I-4M-08/2016(Pt-II) dated 27.05.2019 for examining each Dam Rehabilitation proposal prepared by the SPMU/DRIP for implementation under DRIP and recommending the same for execution. The DSRP has already started their field visit and report preparation. Now, Mr. V.K. Maini, the hydro-Mechanical Expert has expressed his inability to function as a member of the aforesaid DSRP. Moreover, during the first visit of the DSRP members it has been felt necessary to include a Dam Expert in the DSRP.

5. In view of above, the undersigned is directed to inform that the following two members have been included in the DSRP of West Bengal constituted vide this Department's Memorandum No.180-I/I-4M-08/2016 (Pt-II) dated 27.05.2019.
