MEMORANDUM


Irrigation & Waterways Department took a special drive during the last 2 years to keep the drainage channels, in Kolkata and its adjoining urban agglomeration in South 24 Parganas and North 24- Parganas free from water hyacinth, garbage etc through annual maintenance contracts. Similar approach was adopted simultaneously for the municipal areas of Howrah and Hooghly districts. The up-keep of the canal cleaning is being periodically monitored by taking video through drone camera by I.P. Division (South).

It has been felt necessary to enhance the intensity of monitoring of the canal system in the aforesaid area of 5 districts by separate independent team for each district. Accordingly the under mentioned 5 monitoring teams are constituted with defined jurisdictions. Each 3-member team will be headed by a Superintending Engineer.
