MEMORANDUM

Finance Department has published a number of Guidelines & Memorandums relating to procurement tenders from time to time in the recent past.

Finance Department has also modified the delegated powers for technical sanction, administrative approval of works, delegation of power for acceptance of works tenders, and procedure for publishing brief referral advertisement in newspapers for e-tenders, restrictions imposed on splitting of approved schemes and increasing the scope of work during execution phase by restricting the work within the tendered amount (discovered L1 bid price).

There have been a few stray cases of deviations from the prescribed latest Financial Rules in the Irrigation & Waterways Directorate, probably due to ignorance or during quick disposal at various levels. Thus, it is felt that there is a need to prepare a 'Compendium of important Finance Department orders' for ready reference of the engineer officers involved in preparation of schemes and tendering of works in the Directorate.

It may be mentioned that all guidelines and orders of the Finance Department in the matter of Financial Rules and Financial propriety are mandatory for all Departments of the State Government, State autonomous & local bodies including parastatals for strict compliance.

In order to provide a 'Quick Reckoner', most of the latest relevant orders / Memorandums of the Finance Department are summarised in the table next page for convenience at all Directorate level engineers & officers.

All these orders have been made effective by the Finance Department from the corresponding dates of publication of these Orders, Notifications and Memorandums.
