NOTIFICATION

The Governor is pleased to say that in terms of Order No. 504-GA/8P-147/74 dated 14/01/1976 of the erstwhile Home Department, Government of West Bengal read with this Department's Notification No. 26 dated 02/04/2018, Shri Bivabasu Chattopadhyay, Executive Engineer (Civil) of I&W Dte. was appointed as "Officer on Special Duty & Ex-officio Deputy Secretary to the Government of West Bengal, I&W Department" instead of "Deputy Secretary to the Government of West Bengal, I&W Department" with due approval of P&AR Department, Government of West Bengal" as he was enjoying the scale of pre-revised Pay Band- 4A (Rs. 15600-42000/-) with Grade Pay of Rs. 6,600/- which is equivalent to Level-17 (67300/- - 173200/-) of the pay matrix as per pay structure of WBS (ROPA) Rules, 2019 instead of pre-revised Pay Band- 4B (Rs. 28000 – 52000/-) with Grade Pay of Rs.7600/- as per WBS (ROPA) Rules, 2009 in that material point of time.

Now, Shri Chattopadhyay vide this Department's Order No.2751-IE dated 08/09/2022 obtained his next higher scale and attained the Scale or Level- 19 [95,100/- - 1,48,000] of the pay matrix as per WBS (ROPA) Rule, 2019 with effect from the date of 11/04/2021 which is equivalent to pre-revised PB-4B with Grade Pay- Rs.7600/- and also satisfying the criteria of holding the nomenclature of Deputy Secretary as per prevailing G.O of 1976, issued by the Home Department.

In the light of the above observations and consequent upon the approval of the P&AR Department, Government of West Bengal, the Governor is hereby pleased to re-designate Shri Bivabasu Chattopadhyay as "Deputy Secretary to the Government of West Bengal, Irrigation and Waterways Department" with effect from the date of 01/07/2022 in the interest of public service and until further order(s).
