Whereas, even then, it has been observed that a good numbers of application/ advance copy of application have either been submitted through mail to this end or their hardcopies have been submitted to the Department, by the Engineering Officers, holding below the rank of the Chief Engineers, posted in different offices under I&W Directorate, without following the process, as mentioned in Paragraph-2 read with Paragraph-5 of this Department's earlier Notification No. 1579-IE dated 12/06/2024,

Now, therefore, all the Engineering Officers, holding below the rank of the Chief Engineers, posted in different offices under I&W Directorate are further informed to submit their objection/comment of correction in this regard (either through online or offline mode) in compliance with the direction, as mentioned in Paragraph – 2 read with paragraph -3 and Paragraph- 5 of this Department's earlier Notification No. 1579-IE dated 12/06/2024. **No action would be taken against such applications, if received at this end, without following the procedure, as mentioned above.**


