#### NOTICE

The 256 (Two hundred and fifty-six) qualified candidates, whose names are mentioned in the Annexure of this Notice, have been recommended by the Public Service Commission, West Bengal for the appointment to the temporary but likely to be permanent post of Junior Engineer (Civil) borne in the cadre of West Bengal Sub-Ordinate Engineering Service (Irrigation) under Irrigation & Waterways Department, based on the results of Junior Engineers' (Civil/Mechanical/Electrical) Recruitment Examination, 2022-(Civil Branch), vide Commission's Advt. No. 09/2022.
