And, whereas, subsequently, based on the satisfactory Police Verification Report and Medical Examination Report, Sri Ashok Mahata was appointed to the post of Junior Engineer (Civil) vide this department's Notification No. 3851-IW-11011(14)/9/2025 dated 24.12.2025.

And, whereas, Sri Ashok Mahata vide his prayer dated 02.03.2026 has expressed his unwillingness to accept the appointment and join the post of Junior Engineer (Civil) under Irrigation & Waterways Department, citing personal reasons.
