ORDER

In partial modification to this Department Memorandum No.16-(W)/2016-17, dated 14.06.2016 communicated vide Memo No. 57-IB, dated 14.06.2016, the undersigned is directed to convey that technical officers from the mechanical wings of Public Work (Roads) Directorate previously nominated as members in the **Technical Committees of Irrigation & Waterways Department for Condemnation in North Bengal and South Bengal districts** are now being inducted afresh in supersession to earlier placement order in the following manner with immediate effect:

Technical Committee for Condemnation for North Bengal districts would now comprise the following members from the Public Work (Roads) Directorate:

All other contents of the original Memorandum shall remain unaltered.

Concurrence of the Public Works (Roads) Department has been since obtained vide No. PR/N/E/4T-09/13-1282-R/E, dated 10th August 2016 of Chief Engineer (Headquarters), Public Works (Roads) Directorate, Establishment Branch, Kolkata, towards nomination of the aforesaid officers in the Technical Committees for Condemnation for North Bengal and South Bengal districts.

Terms of Reference (ToR) for Technical Committee for Condemnation:

- i. The committees would examine old articles of stock, plant & machinery and equipment (including vehicles) which are lying under different Godown of Divisions in the district offices of I&W Directorate and which may be considered to be beyond economic repair and issue necessary Condemnation Certificate as deemed necessary. The committee would also fix reserve price of old plants, machinery and equipment (also vehicles) in case Condemnation Certificates is issued.
- ii. To review the requirement of plants /machinery and equipments (including vehicles) of different Divisions vis-à-vis their availability and recommend to the Government if some of them may be considered surplus along with the reserved price of such machinery, plants and equipments for

disposal through public auction enjoined in the Rule 47(8) of WBFR, Volume-I and recent modification orders of the Finance Department and notes there under by the parent Division as per delegation of power under WBFR under rule 8 of App.13 of WBFR, Vol-II.

- iii. To review the present inventory of spares available under different Divisions of I&W Directorate, their present and future requirement and recommend to the Government for declaring spares not required in near future as surplus. The committee will also fix the reserved price of the spares considered to be surplus.
 - iv. Old articles of stock (excluding Tools & Plants and machineries) may be disposed off by the concerned Superintending Engineer on the basis of reserve price to be approved by the Technical Committee for Condemnation through e-auction/public auction. Regarding selling of old Tools & Plant and machinery & equipment including vehicles, the reserve price is required to be approved by the Government in the Irrigation & Waterways Department and disposed of through e-auction in conformity with the general guidelines vide Finance Department No. 4068-F(Y) dated 25.05.2015.
2. The committees would be submitting a consolidated report to the Government in the Irrigation & Waterways Department within 31st December 2016.
 3. This order will take immediate effect.
