The undersigned is directed to state that a total of 22 nos. of schemes approved administratively during 2013-14 and 2014-15 under Core State Plan budget at an aggregated cost of ₹ 2027.78 lakh have been identified as non-starter as the financial phasing have been lapsed.

It has been decided in the Departmental Review Meeting held on 16.09.2016 that unless suitable justifications are received from the concerned Chief Engineers within 15 days from the date of issuance of this letter, the 22 schemes as detailed in the Annexure would be treated as abandoned and Administrative Approval be treated as cancelled.
