



He is requested to communicate a copy of this order to each Tahasildar under his control, who is under order of promotion to officiate in the post of Zilladar.

The Tahasildars, under order of promotion, who might have retired from Govt. Service on superannuation, or have expired on or after 1<sup>st</sup> January, 2016, may be deemed to have joined the post of Zilladars with effect from **01.01.2016** and their pay may be fixed accordingly and action may be taken for revision of their benefits under W.B.S.(D.C.R.B.) Rules, 1971, if any, with an intimation to this office.

The Tahasildars under his control should be released immediately, to enable them to join their respective new assignments in the post of Zilladars forthwith and this office may be kept informed of the same. A copy of the release order as well as a copy of joining letter in the post of zilladar, may be sent to this office positively. It may incumbent refuses to accept the promotion, he has to inform his office in writing instantly and the same may be posted in his **Service Book** with necessary entries therein and the said Service Book may be sent to this office for verification, and the provisions of the rules under F.D.No.9120-F dated 13.11.2000 and this office order communicated with memo.no.1137(45)-CIE/7P-01/11 dated 18.04.2011 shall apply.
