**ORDER**

In terms of this office order dated 23-12-2016, communicated vide memo. 5547(35)-CIE-2T-18/2015 dated 29-12-2016 read with subsequent corrigendum dated 30-12-2016, communicated, vide this office memo. 5582(25)-CIE-2T-18/2015 dated 30-12-2016, Shri Debasish Pahari, Regular Beldar (Sl. No. 10 of the list of employees concerned) was transferred from Raidighi Irrigation Sub-Division of Joynagar Irrigation Division under Eastern Circle, I & W. This order takes effect from the date of his joining Contai Irrigation Division, I & W. Directorate.
