Sub: Approval to utilise surplus cut-piece Z-Type M.S Sheet piles of total weight of approx 322.93 MT for other departmental projects within the jurisdiction of Superintending Engineer, Western Circle-II in the Irrigation & Waterways Directorate.

Ref: Report of Chief Engineer (South West) vide No. 725-CI (SW) dated 29.12.2016 addressed to this Department.

It has been reported by him that around 322.93 MT of cut pieces of Z-Type M.S Sheet piles have been determined as surplus after completion of the project due to changed design requirements, originally procured departmentally in connection with RIDF-XVII project for "Reconstruction of Midnapore Anicut Structure on River Cossye" under West Midnapore Division.

It has been further proposed by him that these cut piece Z-Type M.S Sheet Piles may be permitted to be utilised for works shortly to be commenced under Contai Irrigation Division of Western Circle-II, Irrigation & Waterways Directorate.

The Z-Type M.S Sheet Piles were procured departmentally and in the instant case site accounts transfer from one Division to another Division office within the same Circle office is involved. Utilisation of above cut piece material would be beneficial to the Government without compromising quality in any manner.

The undersigned is hence directed to convey the approval of this Department for intra-Circle transfer of Govt. materials in the Irrigation & Waterways Directorate referred above as a special case, subject to the condition that deduction of costs from works bills where it shall be utilised shall be as per prevailing procurement/issue rate of the Z-Type M.S

Sheet piles in each and every bill for payments of items involving these Z-Type M.S Sheet Piles.

This order issues as per recommendation of Financial Advisor and approval of Principal Secretary of this Department.
