The undersigned is directed to say that pursuant to the Departmental Review Meeting held on 06.02.2017, allocation of fund under Core State Plan for taking up new schemes having an aggregate estimated cost of Rs. 725.64 crore comprising financial phasing in 2017-18 of Rs. 190.60 crore was communicated vide this Department Memo No. 410(7)-IB dated 01.03.2017, which may be seen in the 'Order link' of the Departmental website.

1. Improvement of Distributory Canal No. 1/3 of Mayurakshi-Bakreswar-Main-Canal in Blocks Suri-II and Sainthia under Mayurakshi Headquarters Division.
2. Improvement of Bakreswar-Kopai-Main-Canal under Block Dubrajpur under Mayurakshi South Canals Division.
