Agenda: Short listing of new Projects in conformity with the Departmental allocation under Core State Plan budget relating to infrastructure development during the current financial year of 2017-18.

Secretary took the chair. Financial Advisor, Chief Engineer (South), Chief Engineer (North), Chief Engineer (West), Chief Engineer (South West), Chief Engineer (Design & Research) and other officers remained present.

The following were discussed:

1. Technically sanctioned DPR of 30 new schemes at an aggregate estimated cost of Rs 41.21 Crore, were submitted by the Chief Engineers mainly involving infrastructure development works.
2. After scrutiny of budget allocation it was seen that only around Rs. 18.00 crore is available for infrastructure development & electro-mechanical works after including savings in earmarked schemes allocated in the Departmental Review Meeting held on 6.2.2017.
3. In the above context, after a threadbare discussion, the Chief Engineers scrutinised and prioritised 17 no. infrastructure development & electro mechanical schemes at an aggregate cost of Rs. 19.89 crore

and 2 no. of field schemes out of earmarked allocation for field schemes of Chief Engineer (South) at an aggregate cost of Rs. 37.18 crore, summarised at Annexure-I so as to restrict the overall cost more or less as per allocation fixed in the Departmental Review meeting.

4. Chief Engineers further stated that the remaining schemes summarised at Annexure-II relates to development of infrastructure are also very important and needs to be taken up. Three new infrastructure development schemes relating Quality Control Laboratories at Salt Lake in North 24-Parganas, Galsi in Purba Bardhaman and Coochbehar town, at identified locations would be discussed and cleared under Core State Plan in the next Departmental Review Meeting.
5. Decision regarding the remaining schemes as per Annexure-II will be intimated at a later stage. Suitable financial phasing of expenditure would be decided as per voted budget fund availability spread over in two financial years, viz 2017-18 and 2018-19.
6. It was stated by the Chief Engineers that there is no duplication of proposal with other sources of funding. All the schemes have been selected on the basis of ground requirements.
7. Finally after minor corrections in nomenclature, 17 no. of schemes relating to infrastructure development and electro-mechanical works at an aggregate cost of Rs. 19.89 crore and 2 no. of field schemes at a cost of Rs. 37.18 crore, totalling Rs. 57.07 crore were approved by the DSC for inclusion under Core State Plan Budget of this Department during the current financial year of 2017-18. Tenders may be invited immediately.

The meeting ended with vote of thanks.
