**Agenda:** Short listing of new projects under Core State Plan within the additional approved allocation during the current financial year of 2017-18.

Secretary took the chair. Financial Advisor, Chief Engineer (South), Chief Engineer (North), Chief Engineer (Design & Research) and other officers remained present.

The following were discussed:

1. Initially, technically sanctioned DPR of 23 schemes at an aggregate estimated cost of Rs 65.81 crore, were placed before the DSC within the allocation fixed in the departmental review meeting held on 30.06.2017.
2. Four of the originally proposed schemes were set-aside after examination. One scheme of Jalpaiguri district was found to have been sanctioned already under RIDF and another in the same district relating to Teesta Barrage Project is maintenance in nature, for which administrative approval is not required. One estimate relating to signage display units for Teesta Barrage Project is decided to be borne out of Plan Maintenance funding. The DPR relating to improvement of Mayurakshi Bakeswar Main Canal in Birbhum district was returned to the Chief Engineer (North) with a request to comply the technical guidelines of Central Design Office and resubmit it in the next DSC meeting.

3. Two new technically sanctioned copy of DPRs were placed by Chief Engineer (South) in the meeting for consideration, within the approved allocation.
4. After a threadbare deliberation, 20 schemes were cleared in the meeting with minor corrections in names etc. Chief Engineers certified that there is no duplication of any proposal with other source of funding. All the schemes have been reported as selected on the basis of prioritised ground requirements.
5. Chief Engineer (South) was requested to frame a revised estimate after completion of 2.00 km stretch Kestopur canal beautification work including all the individual component projects sanctioned.
6. Finally all the 20 schemes at an aggregate cost of Rs. 29.17 crore were recommended by the DSC for inclusion under Core State Plan Budget of this Department during the current financial year of 2017-18. Financial phasing of the schemes would be suitably determined in due course in conformity with head of account wise budget fund availability.

The meeting ended with vote of thanks.
