ORDER

The Governor has been pleased to accord permission in terms of **Rule 5(2) of W.B.S.(Duties, Rights & Obligations of Govt. Employees) Rules,1980 read with No.1853-F(P) dt.2.3.12** in favour of Sri Indranath Mukherjee, Assistant Engineer(Civil), Kangsabati Canals Sub-Division No. X, Irrigation & Waterways Directorate to purchase a piece of land measuring 1440 sq ft. or 2 cottah or more or less, for residential purpose situated in R.S. and L.R. Plot No.171 of Mouza-Kanainatsal, J.L. No.76, within P.S. and District-Burdwan, at the consideration price of **Rs.14,69,000/- (Rupees Fourteen Lakh Sixty Nine Thousand) only**, inclusive of Govt. duties etc. jointly with his wife.

This order is issued subject to the condition that Sri Mukherjee will remain answerable to the Govt. if any of the furnished facts/documents is found to be false/ incorrect in later date.

The said property should have been reflected in returning of declaration of asset.
