Record of discussion of the Departmental Review Meeting, taken by the Additional Chief Secretary on 10.05.2018, with the Investigation & Planning Wing and Advance Planning cell at 11:00 A.M. in the conference room at 1stfloor of Jalasampad Bhavan, Salt Lake

The meeting was chaired by the Additional Chief Secretary, Irrigation & Waterways Department. The Superintending Engineer, Investigation & Planning Circle –I, Superintending Engineer, Investigation & Planning Circle –II, Director, Advance Planning made separate Power point presentations on existing manpower vis-a-vis sanctioned strength, work distribution among different divisions and future plans/ works to be taken up. During discussion, it transpired that some of the divisions/ sub-divisions are lying redundant and their work jurisdictions need reorientation for optimum utilization of the service of available manpower. After detailed discussion, the following decisions were taken:-

a. The administrative control of the Advance Planning PPEMC is to be shifted to the control of the Chief Engineer (D&R), Irrigation & Waterways Directorate from

- Director (Personnel). A departmental order in this regard will be issued. (Action: Irrigation & Waterways Department)
- b. The Annual Plan, published by the APPMEC, has lost its relevance and needs not to be prepared henceforth. (Action: Director Advance Planning)
- c. The 1st edition of the statistical handbook published in December, 2016 needs to be revised. The next version is to be published by August-2018. (Action: Director Advance Planning)
- d. Applications are being received regularly from various government departments / organizations, educational institutions etc. for supply of historical data/ information relating to rainfall, river gauge levels, discharge, silt content, road statistics etc. A substantial time is used up in processing such applications. Moreover, same data are supplied on different occasions to different institutions. Considering this, it was decided that the Advance Planning Cell will supply available historical hydrometeorological data in excel or word format to the Executive Engineer, e-gov cell for uploading the same in the departmental web portal at a designated menu bar. The same can then be accessed by anyone within or from outside the department. Executive Engineer, e-gov cell will take necessary action for creating the said menu bar and uploading the supplied non-classified data meant for being put in Public Domain. (Action: Director Advance Planning and E.E/e-governance cell)
- e. The Land Bank prepared by the department earlier in 2012 needs revision. The APPMEC will send a format to all concerned to obtain necessary information for revision of the Land bank inventory. The revised and modified version is to be published by 31.08.2018. (Action: Director Advance Planning)
- f. It was informed by the Director, APPMEC that information / data required for digitisation of available information/ maps/ drawings etc. is received from different corners barring from the Superintending Engineer (Damodar Irrigation Circle). The same should be collected from Superintending Engineer (Damodar Irrigation Circle) immediately and the tender to be invited within 31.05.2018 under NHP. (Action SPMU/NHP and SE/DIC)
- g. Sri Diganta Maity, Deputy Director, APPMEC is to be released from his existing posting within next 7 days to join his new assignment under SPMU of WBMIFMP. (Action Director, APPMEC)

- h. It was informed by the Superintending Engineer, Investigation Planning Circle-I that on several occasions Project Completion Reports (PCRs) and utilisations of Last drawls of RIDF schemes are being submitted at delayed dates. It was decided that provision of submission of those two reports online would be made in the online plan fund monitoring module. Hence forth, the Superintending Engineer, Investigation & Planning Circle I will remain present in the departmental review meeting with Chief Engineers. (Action SE, IPC-I)
- i. The Investigation & Planning Circle-I will engage an agency to observe daily gauge and discharge data of Shortcut channel at Sehaguri and Amta Channel at Amta, by ADCP during the ensuing monsoon period (15th June to 15th October). The Investigation & Planning Circle- I will also continue discharge observation at Harinkhola and Champadanga through ADCP by deploying an agency during the monsoon period. Necessary arrangement also would be made by them to send the data to flood control room. (Action SE, IPC-I)
- j. The Investigation & Planning Division (Central), Berhampore, Investigation & Planning Sub-division-I at Barasat under Investigation & Planning Division (South) and the Chinsurah Investigation Sub-Division under Bardhman Investigation Division are to be re-structured. The Chief Engineer (Design & Research) will send a proposal of reorientation of the aforesaid divisions and sub-divisions to the Department by 30.05.2018. Thereafter, relevant order from the department will be issued. (CE,D&R)
- k. In continuation to the phase-I work of Arambag Master Plan for Arambag, Khanakul-I and Khanakul-II amounting to Rs.52 Crore, D.P.R of phase-II of the said master plan is to be prepared for Goghat-I & Goghat-II blocks. Damodar Survey Investigation Division will complete the balance survey and submit the project proposal to the Hooghly Irrigation Division by 30.06.2018.
- 1. Both IPC-I & IPC-II will send a list to the department mentioning the schemes for which survey has already been conducted by them but implementation of related schemes are awaited.
