Subject : Installation of Grid Connected Rooftop Solar Photovoltaic (GRTSPV) Systems with net metering arrangement at the different buildings of Irrigation Department under Aloshree Programme.

In inviting a reference to the above letter regarding the subject mention above, the undersigned is directed to state that the West Bengal Renewable Energy Development Agency (WBREDA) under Power & NES Department has decided after technical site survey that GRTSPV systems of cumulative capacity 255 kWp out of 531 kWp can be installed on the buildings as per Annexure-I in 1st phase. M/S Sunshine Power products Pvt. Ltd. has been engaged by WBREDA for installation of the GRTSPV Systems at the said buildings. The installation process is in progress and will be completed within August-2018. In the meantime, it is necessary to take up the matter to the local WBSEDCL Office by the concerned Executive Engineer/Nodal Officer for completion of the stipulated formalities for Net-Metering arrangement with WBSEDCL so that immediately after installation, the PV Systems can be tested and commissioned.

In referring to the Annexure-II & Annexure-III of this letter, the undersigned is further directed to request him to nominate district-wise Nodal Officers and send a list mentioning contact number directly to the WBREDA for keeping contact with WBREDA and also direct the Executive Engineer under his control for providing co-operation to the agency enabling them to install the said GRTSPV Systems in 1st phase & as well as to conduct technical site survey for the 2nd phase.
