The Department took a special step to introduce detailed examination and scrutiny of the completed and ongoing plan works by constituting 10 separate teams comprising of Departmental Officers (Technical Examination Teams) for conducting technical audit at different zones across the State vide this Department's Order No.29 (W)/2016-17 dated 09.11.2016. The basic objective was to examine a plan scheme, starting from its planning to its complete execution and to check if the prescribed rules in making payment, transparency in tendering, quality checking during examination and adequate field investigation during planning stage to avoid overlap of zone of works, have been strictly adhered to.

With a view to improve and proper maintenance of irrigation canals systems of Teesta Barrage Project, Chief Engineer, Teesta Barrage Project, Irrigation & Waterways Directorate was requested by this end to prepare and submit plan in this regard. In response, Chief Engineer, Teesta Barrage Project, has sent reports on one-time repair cost of continuous reaches of different canals along with structures under Teesta Barrage Project submitted to him by the Superintending Engineer, Mahananda Barrage Circle and the Superintending Engineer, Teesta Barrage Circle. It has been decided in this Department to examine the entire proposal by two Technical Examination Teams (TET) constituted vide this Department Order No.29 (W)/2016-17 dated 09.11.2016.

In view of above, the undersigned is directed to inform that the following TET (ID No. N1 and NE2) will be conducting the technical audit on the proposals of one time repair cost of continuous reaches in different canals along with structures of the canal systems of Teesta Barrage Circle and Mahananda Barrage Circle as assigned against each team.

Each team would examine the entire proposal in respect of the entrusted zone on the followings:

- i) Justification/ Requirement of the proposed work.
- ii) Whether the proposal is framed based on actual ground reality and following technical guidelines.

- iii) Whether the cost estimation as submitted by Teesta Barrage Project authority is realistic.
- iv) Suggested modification during preparation of the cost estimate.
- v) Any special maintenance measure if required in the canal network system.

The TET will submit its report to the Department by 30.11.2018 along with their views / suggestions regarding further course of action to be taken for proper maintenance of the entire canal system.
