**Sub:** Submission of Action Plan for polluted River Stretches, categorized as Priority-I, II, III, IV and V in compliance to the order of NGT O.A. 673/2017 and O.A. 727/2018.

**Ref:** Memo No-NGRBA/SPMG/AP-NGT-505/2018 dated 15.01.2019 of the Program Director, WBSPMG & Member Convener of the River Rejuvenation Committee (RRC), constituted by the Urban Development Department, Government of West Bengal under the chairmanship of the Additional Chief Secretary, Environment Department, Government of West Bengal.

In enclosing a copy under reference, the undersigned is directed to inform that the River Rejuvenation Committee, as stated above, has asked all the concerned departments to submit action plan against each of the identified stretches of rivers (17 nos.), detailed and categorized as Priority-I to V,

positively by 28.01.2019. During the 1<sup>st</sup> meeting of the committee on 18.01.2019, the Irrigation & Waterways Department was also requested to take part in a joint site visit with Environment Department for the identified stretch of Vidhyadhari river. Accordingly the officers from Calcutta Drainage Outfall Division and Metropolitan Drainage Division-I have taken part in the said joint site visit on 20.10.2019 and furnished required information to the scientists of the Environment Department.

2. The Irrigation & Waterways Department has also been requested to submit Action Plans on each of identified 17 river stretches. In view of above, the undersigned is requested to submit the detail action plan for each river stretch to the Department positively by 25.01.2019 in the following format.
