Office Order

A complain has been received at the Department on the Notice Inviting Tender No-01 of 2019-20 of the Executive Engineer-I, Lower Damodar Irrigation Division, Irrigation & Waterways Department relating to execution of 142 no Maintenance Works at different stretches of irrigation canals, drainage channels, embankments, river banks etc. alleging unnecessary splitting of works. It is also not clear if the total amount put to tender in the instant NIT is within the approved financial allocation of the Department against the executive Engineer-I, Lower Damodar irrigation Division and the prior approval of the Superintending Engineer was obtained on the list of works included in the said NIT.

In view of above the undersigned is directed to inform that an Enquiry Committee in the Department is constituted with the following composition and terms of reference.

Compositions:

1. The Chief Engineer (Design & Research), Irrigation & Waterways Directorate, Chairman.
2. The Additional Project Director-I, SPMU, WBMIFMP, Irrigation & Waterways Directorate, Member.
3. The Executive Engineer, Howrah Irrigation Division & the DPIU, WBMIFMP, Howrah, Member.
4. The Project Manager, Head Quarter, SERP, Irrigation & Waterways Directorate, Member.

Terms of reference:

1. The Committee will undertake site visits and examine all the documents relating to the works recently (within last 2 years) executed in the reaches mentioned in the NIT.
 2. The committee will also examine if prior approval of the Superintending Engineer/Damodar Irrigation Circle was obtained on the proposed list of maintenance works.
 3. The Committee will examine the reason behind going for 142 nos. of spilled works instead of canal wise single work.
 4. The Executive Engineer-I, Lower Damodar Irrigation Division and the Superintending Engineer/Damodar Irrigation Circle will provide all the related documents to the committee, as and when asked for.
 5. The Committee will submit its report to the Department within 30 days.
- The Executive Engineer-I, Lower Damodar Irrigation Division will arrange all the logistic support to the Committee, to undertake site visit and examination of documents.
