Records of discussion of the Review Meeting taken by the Secretary on 28.05.2019 at Jalasampad Bhawan, Salt Lake to monitor the process of e-auction of unserviceable materials in the South Bengal districts being conducted through MSTCL

The meeting was commenced under the Chairmanship of the Secretary, Irrigation & Waterways Department at 12 noon.

The following issues were discussed in the meeting:

- 1. The Chief Engineer (Design & Research) appraised the house that out of 175 lots in the 1st Phase of e-auction through MSTCL, consisting of mainly various scraps and vehicles, 145 cases has been completed and 30 nos. of lots are still under process due to various reasons.2nd phase of auction has been stated under MDC, GCDC, Purulia and RRI.
- 2. The Secretary, wanted to know the status of 30 pending cases. Superintending Engineer, Eastern Circle informed that out of pending cases, 4 nos. of lots have to be canceled and re-auctioned due to discrepancies in the quantity.
 - As bid money has already been deposited in aforesaid four cases through GRIPS, Finance Department has to be approached for their refund. FA stated that, proper justification should be submitted to Irrigation & Waterways Department for recommending it to the Finance Department.
- 3. It has been noticed that some auctions did not mature even after 3rd call. It was decided in the meeting that case specific proposals should be submitted to the Department along with the recommendation of the Directorate Level Technical Condemnation Committee in order to reduce the Reserve Prices explaining the facts.
- 4. The Superintending Engineer, Kangsabati Circle-I, stated that re-auction for 6 nos. lot which were pending have since matured on 27.05.2019, and the lifting order would be issued after depositing required bid money.
- 5. 2 nos. lot of Kangsabati Circle-II which were of meager quantity for which no bidder has shown interest. It was decided that the lots will be merged with other lots and reauctioned.
- 6. OSD Purulia was requested to segregate the Hume pipes in good conditions for re-auction
- 7. Issuance of Delivery challans should be commensurate with the auction notice. If the auction has been invited in lots, the corresponding Delivery challan should also be in lot.
- 8. It was also discussed that all lots should be clearly segregated and demarcated to avoid any confusion during physical verifications / lifting by the bidders.
- 9. Metal Scrap & Trading Corporation Limited requested the concerned circle offices to mention the heads of account related to their circle for depositing bid money during

sending of the list of MSTCL for auction.

10. It was decided that after passage of 21 days from the auction finalisation date, the EMD of the defaulting bidders would be directly forfeited. However after 14 days till 21 days from the auction finalization date, late payment charges would be levied. Re-auction shall be invited thereafter.

The meeting ended with vote of thanks.
