The concerned Executive Engineers also remained present.

Agenda: Recommendation of new schemes for accordance of administrative approval under State Development Schemes Budget of this Department for 2019-20 under 2nd phase of Departmental allocation for 2019-20.

Secretary took the chair. Financial Advisor, Chief Engineer (North), Chief Engineer (South), Chief Engineer (West) and other officers remained present.

The following were discussed:

1. Technically sanctioned DPR of 34 no. of new schemes at an aggregate cost of Rs. 82.35 crore were initially placed in the meeting. Further proposals for 3 no. of new scheme were placed in the meeting.
2. 7 (Seven) schemes relating to protection of Bhagirathi / Ganga-Padma rivers were returned for resubmission. Anti erosion work is to be taken up first. Then in the next working season after passage of a monsoon the bank protection work should be taken up.
3. A threadbare discussion was held on the technical aspects of each of the schemes.
4. The DSC scrutinized the remaining 30 no of DPRs' in conformity with the Departmental manuals and necessary corrections were made.
5. Nomenclatures of a few schemes were modified to make them commensurate with the capital works and some minor corrections were incorporated. Cost of a few schemes was modified on technical reasons.
6. The Chief Engineers certified that there is no duplication of proposals with any other sources of funding, and all the schemes have been selected by them on the basis of prioritized ground level requirements.
7. Finally, 30 (thirty) no. of new schemes at an aggregate cost of **Rs. 68.13 crore** as per enclosed list (Annexure) were cleared by the DSC for inclusion under State Development Schemes Budget of 2019-20.
8. Tenders are to be invited immediately for works upto value of Rs. 20 crore.


