### <u>ORDER</u>

In terms of Memo. No. 296(9)-IE-3M-21/2017 dated 29.11.2019 & Memo. No. 849(9)-IE-3M-21/2017 dated 29.03.2019 of this Department all the Chief Engineers under Irrigation & Waterways Directorate, West Bengal were requested to forward the names of the contractual/casual/daily rated employees engaged by this Department with specific approval of the Finance Department and drawing remuneration from the treasuries or from grant-in-aid under their jurisdiction as per prescribed format (Form-'B') to the concerned District Magistrate Office to enrol them under "Swasthya Sathi Scheme".

It is gathered that large number of contractual workers under this Department have not yet obtained their "Swasthya Sathi Card" and they can't avail the benefit of this Government's scheme.

Considering the above circumstances, the Governor is pleased to direct all the Chief Engineers under Irrigation & Waterways Directorate, West Bengal to organise a camp on the 2<sup>nd</sup> Week of December. 2019 to expedite the enrolment system under "Swasthya Sathi Scheme" in respect of the Contractual Employees posted under their jurisdiction.

They should appoint a Liaison Officer, who will keep close liaison with District authorities and will take a roll to expedite the process. This task should be executed in the period of one week.

Consequently, Chief Engineers concerned will organise a 2<sup>nd</sup> Camp on the 4<sup>th</sup> Week of December, 2019 in this regard and furnish a satisfactory report to this Department before 31<sup>st</sup> December, 2019 positively.

This should be taken as top priority.

All concerned are being informed accordingly.
