**Sub:** Insertion of Legacy Projects (ongoing plan works) in the AAFS module during 2019-20.

Functioning through 'Administrative Approval and Financial Sanction (AAFS) Module' was made mandatory by the Finance Department vide their Memo No. 2131-F(Y) dated 05.04.2019 through introduction of IFMS 2.0 version during the current financial year of 2019-20. As part of this exercise, Administrative Approval and Financial Sanction to projects shall be accorded through AAFS Module and thereafter, release of funds shall also be made project-wise through AAFS Module under SDS & SDS (CA) Budget Provision.

Hence, the projects administratively approved in the FY 2018-19 and prior to 2018-19 under any source of fund except Administrative Expenditure (Non-Plan & Plan Maintenance Project) should be treated as legacy project. As such, insertion of all legacy projects in AAFS module has become mandatory for release of fund.

Now, the undersigned is directed to state that insertion of legacy project should be completed within March'20 without fail in order to ensure the release of fund. A 'Proforma' relating to the legacy projects for which no fund since been released by this Department is attached with this order for the purpose stated above and the Chief Engineers are requested to compile the report as per the prescribed Proforma and submit the same within 15 January 2020.
