The concerned Executive Engineers also remained present in the two meetings.

Agenda: Recommendation of 5 (five) new schemes for inclusion under Core Sector State Development Schemes voted budget of Irrigation & Waterways Department during current FY of 2020-21.

Secretary took the chair and Departmental Financial Adviser with other Officers of the Department and the Directorate stationed at the Jalasampad Bhawan Head Quarters was present at Jalasampad Bhavan Conference Hall. Chief Engineer (South West) at Midnapore and other district officers at Contai office, connected on Zoom App.

The following were discussed:


1. Technically sanctioned DPR of 5 no. of new schemes at an aggregate cost of Rs. 9.49 crore were initially placed in the meeting.
2. A threadbare discussion was held on the technical aspects of each of the schemes.
3. The scheme posed under Sl. 2 (RCC bridge at Gorsauri over Mogra Khal), under Sl. 4 (RCC bridge at Vetukia-Gayanbari over Tegua Khal) and Sl. 5 (RCC bridge at Keshabpur) have been designed by the Central Design Office of Irrigation & Waterways Directorate. The schemes under Sl. 2 & 4 are in Purba Medinipur District over drainage khals maintained by Irrigation & Waterways Department connecting village roads.
4. The scheme under Sl. 5 discussed on 29.9.2020 is in connection with a proposed RCC bridge at Keshabpur under Block & P.S Baruipur, District South 24-Parganas replacing the existing old dilapidated cart bridge over Suryapur Inner Channel where roads at both banks connect to roads maintained by Public Works (Roads) Directorate. The existing dilapidated cart bridge was constructed decades back by I&WD and now has become beyond economic repair. The drainage canal Suryapur Inner Channel of I&WD is located outside the KMDA area.
5. Nomenclatures of a few schemes were modified to make them commensurate with the capital works and some minor corrections were incorporated.
6. The Chief Engineers certified that there is no duplication of proposals with any other sources of funding, and all the schemes have been selected by them on the basis of prioritized ground level requirements.
7. Finally, 5 (Five) no. of new schemes at an aggregate cost of **Rs. 9.49 crore** as per enclosed list (Annexure) were cleared by the DSC for consideration by the Finance Department for inclusion under Core Sector State Development Schemes budget of I&WD under Demand No. 32, B.P no 18 during the current FY 2020-21 in relaxation to the existing orders.
