Agenda: Recommendation of 12 (twelve) new schemes for inclusion under Core Sector State Development Schemes voted budget of Irrigation & Waterways Department during current FY of 2020-21 under Paray Samadhan Campaign.

Secretary took the chair and Departmental Financial Adviser with other Officers of the

Department and the Directorate stationed at the Jalasampad Bhawan Head Quarters was present at Jalasampad Bhavan Conference Hall. Chief Engineer (South West) at Midnapore, Chief Engineer (North East) at Jalpaiguri Headquarter and other district officers at Contai and Bardhaman offices were connected on Zoom App.

The following were discussed:

1. A total of 146 no. of grievances have been registered and uploaded in the web portal ds.wb.gov.in relating to Paray Samadhan / Duare Sarkar as on 06.01.2021. Out of the said complaints 71 nos. relates to works under I&WD. This Department in terms of meeting taken by the Chief Secretary on 30.12.2020 has decided to prioritize 39 works each of which are within Rs. 1 crore value and can be grounded by 20th January 2021.
2. Out of the 39 works, 17 schemes relates to Capital Expenditure hence is proposed under SDS budget of this Department and the remaining 22 are maintenance works. Out of these 17 schemes DSC has already cleared 4 previously and hence the remaining 13 were placed in this meeting for approval of the DSC.
3. A threadbare discussion was held on the technical aspects of each of the schemes, 12 schemes were cleared and 1 no. scheme relating to 'Construction of a cross over structure' was excluded due to absence of design and drawing.
4. Nomenclatures of a few schemes were modified to make them commensurate with the capital works and corrections in estimated costs were recommended.
5. The Chief Engineers certified that there is no duplication of proposals with any other sources of funding, and all the schemes have been selected by them on the basis of prioritized ground level requirements.
6. Finally, 12 (twelve) no. of new schemes at an aggregate cost of **Rs. 6.97 crore** as per enclosed list (Annexure) were cleared by the DSC for consideration for administrative approval under Paray Samadhan Campaign under Core Sector State Development Schemes budget of I&WD under Demand No. 32, B.P no 18 during the current FY 2020-21 in terms of the existing orders.
7. Tenders may be immediately invited in terms of Finance Department Order No. 1-F(Y) dated 02.01.2021 so that work orders may be issued within 18.01.2021.
