held at Jalasampad Bhavan, Salt Lake on 25.01.2021.**

The concerned Executive Engineers also remained present.

Agenda: Recommendation of 2 (two) new schemes for inclusion under Core State Development Schemes (Voted) budget of Irrigation & Waterways Department during the current FY of 2020-21.

Secretary took the chair.

The following were discussed:

1. Technically sanctioned DPR of 2 no. of schemes at an aggregate cost of Rs. 4.89 crore were placed in the meeting.
2. A threadbare discussion was held on the technical aspects of each of the two schemes. The scheme relating to bank protection of River Ganga at Dhulian Municipality in Murshidabad is located within the proposed extended jurisdiction of the Farakka Barrage Project Authority of GoI. Some stop-gap palliative works were undertaken by the FBP

and later by I&WD which have been fully damaged and is unable to arrest the massive erosion and has thus proved inadequate. The instant scheme has been prepared based on the technical guidelines contained in the Departmental Manual. The Chief Engineer (North) was requested to rectify the anomaly in the volume of nylon crated HDPE bags used for aprons and side slopes. The necessary modifications were made in the nomenclature of analysis of rates.

The 2<sup>nd</sup> scheme related to construction of a sluice structure replacing the old dilapidated sluice on Kalnagini khal has been prepared based on the design and drawing of the Central Design Office, I&W Dte. However, the concerned Superintending Engineer of Eastern Circle was requested to verify the current market rate of sheet piles and incorporate the same in the cost estimate. The Superintending Engineer has since certified in the DPR that the rate for procurement of U type sheet pile is unchanged.

3. The Chief Engineers stated that there is no duplication of proposals with any other sources of funding, and both the schemes have been selected by them on the basis of prioritized ground level requirements.
4. Thus, 2 (two) no. of new schemes at an aggregate cost of **Rs. 4.89 crore** as per enclosed list (Annexure) were cleared by the DSC for inclusion under Core State Development Schemes budget of I&WD under Demand No. 32, B.P no 18 during the current FY 2020-21 under delegated power to the Department.


