The suspension order dated 24th July, 2018 issued by the office of the undersigned in terms of Rule 7(3) under Part-IV of the West Bengal Services (Classification, Control and Appeal) Rules, 1971 so communicated vide this office Memo No. 4130/1(5)-CIE/3M-39/18 dated 25.07.2018 in respect of Sri. Jarman Murmu, Head Clerk of the Office of the Superintending Engineer, Mayurakshi Canal Circle, I & W Dte. is hereby revoked and he is hereby reinstated in service with effect from 05.02.2021 (FN) on his acquittal from the charges made therein vide judgement dated **29.02.2020** passed by the Hon'ble Judge (1st Special Court), Birbhum, in Special Case No. 01 of 2018 (State Vs. Basudeb Mal & Ors).

The pay and allowances of the said Government employee would be governed by Rule **72 A** of the West Bengal Services Rules, Part-I.

Besides this, the period of suspension of Sri. Murmu (from 16.07.2018 to 04.02.2021) would be treated as '**Spent on Duty**' and it is strictly applicable to all purposes, in respect of Sri. Murmu for the aforesaid period.
