The undersigned is directed to say as per report received from the Departmental Nodal Officer for RIDF works i.e the Chief Engineer (South), Irrigation & Waterways Directorate, the DPRs of 72 schemes have been submitted to NABARD, Kolkata Office in the following manner based on the scheme wise allocation after undertaking internal technical scrutiny at various levels, and no further proposal out of Departmental allocation is pending for submission.

Thus, there is saving of Rs. 6.36 crore after actual finalization of the DPRs and hence based on the HPC allocation for RIDF-XXVII of Rs. 690 crore, identification of further additional schemes have become necessary.

The undersigned is now directed to convey the additional list of 3 schemes located on the prioritized sector Ganga / Padma-Hooghly river system at a tentative estimated cost of Rs. 10.49 crore as detailed in the Annexure to this order for submission of the same to the NABARD under RIDF-XXVII during 2020-21 and taking up the projects upon obtaining sanction from NABARD during 2021-22.

The concerned Chief Engineers are requested to submit the DPRs after statutory clearances as applicable, at the disposal of Chief Engineer (South) for enabling him to submit those to NABARD preferably within 28th February, 2021, under intimation to Finance Department under RIDF-XXVII.
