Records of discussion of the Departmental Review Meeting held on 13.07.2021 in the 1st Floor Conference Hall of Jalasampad Bhavan, Salt Lake.

The meeting was presided over by the Hon'ble Minister-in-Charge, Irrigation & Waterways Department.

In addition, all Secretariat officers of the works branch and the Chief Engineers posted at Head Quarters were present.

Agenda-1: Selection of new schemes under Core Sector SDS budget of this Department during 2021-22.

- 1. List of schemes prepared by the Chief Engineers comprises 264 projects at an aggregate estimated cost of Rs. 1132.22 crore was presented in the meeting.
- 2. During the meeting, 107 projects out of the said 264 projects were selected as the 1st phase of 2021-22, for consideration for accordance of administrative approval as per <u>Annexure</u> based on following considerations:
 - Delegation of administrative approval power in favour of this Department, accorded by the Finance Department vide their no. 1971-F(Y) dated 30.06.2021 (i.e project costing upto Rs. 1.50 crore).
 - ii. Budget information for the financial year 2021-22 based on AAFS.
 - iii. Commitments of the Department.



- 3. The list of these 107 projects selected in the meeting have been re-assessed by the Chief Engineers towards necessity for taking up of such projects, as per policy and guidelines of the Department and that of the Finance Department, particularly in the present scenario.
- 4. The same list of 107 projects is also being sent to the Superintending Engineer & Member-Convenor, Investigation & Planning Circle-I, Irrigation & Waterways Directorate for taking up the following actions:
 - i. DPR of schemes costing within and upto Rs. 5 crore are required to be submitted by the concerned Chief Engineers before the Directorate Level Technical Committee for further scrutiny, and those above values of Rs. 5 crore are to be placed before the Technical Committee of Chief Engineers for their examination and recommendation before placing all the schemes (both below Rs. 5 crore and above Rs. 5 crore) to the Departmental Screening Committee.
- 5. The list of 157 projects (264 projects 107 projects) are required to be serial wise prioritised by the concerned Chief Engineers and re-submitted to this Department for consideration under Phase-II, for administrative approval under Core Sector SDS budget. These DPRs need not be finalised at this stage.
- It was decided to accord administrative approval of SDS maintenance works for premonsoon of 2021 with the concurrence of FA under delegated power.
- 7. It was further decided to submit a proposal to the Finance Department for their concurrence for increasing the Additional Performance Security from existing 10% to 30% of L1 bid price in all works tenders, in an effort to curtail the continuing tendency of quoting abnormally low rates in tenders.

Agenda-2: Physical verification of unused Departmental land and initiate process for settlement of encroached land through Land & Land Reforms, Refugee Relief and Rehabilitation Department

1. Land bank of Irrigation & Waterways Department was prepared during 2012 and plot wise vacant land was identified based on records. During 2018, the same land bank was updated under the Advance Planning, Project Evaluation and Monitoring Cell of I&W Directorate which shows 1902.12 acre of vacant land spread over 13 districts. Many of those vacant lands have been reportedly encroached without authorisation by the



Government. Thus, it was discussed in the meeting to initiate physical verification of these vacant lands and identify the unauthorised occupants on land plans and thereafter move the Land & Land Reforms, Refugee Relief and Rehabilitation Department for their suitable settlement. The Nodal Officers for this activity shall be the Joint Secretary (Revenue) in the Irrigation & Waterways Department and the Director, Advance Planning, Project Evaluation and Monitoring Cell in the Irrigation & Waterways Directorate.

The meeting ended with vote of thanks to and from the chair.
