held at Jalasampad Bhavan, Salt Lake on 02.08.2021.**

Agenda: Proposal for recommendation of 2 (two) new schemes for inclusion under Core State Development Schemes (Voted) budget of Irrigation & Waterways Department during the current FY of 2021-22.

Secretary took the chair.

The following were discussed:

1. DPR of following 2 no. of schemes included in the list of 107 schemes selected in the Departmental Review Meeting taken by Hon'ble MIC on 13.07.2021 were placed in the meeting:

- i) Renovation of head works structure of Tarkey Minor Irrigation scheme in Block Gopiballavpur-I, P.S Gopiballavpur, District Jhargram under Jhargram Flood Management & Planning Division.
 - ii) Rehabilitation of 13 no. structures comprising 6 no. RCC bridges at ch. 1122.30, 1758.00 of TSMC(N), ch. 25.00, ch. 40.00 of Dy-13R of TSMC(N), ch. 318.50 of TSMC(S), ch. 138.50 of Dy-22R/TSMC(S) and 7 other structures i.e RCC bridge cum-fall-structure at ch. 230.00, ch. 460.00 of TSMC(S), ch. 173.50 of Dy-18R/TSMC(S), ch. 267.90 of Dy-18R/TSMC(S), ch. 0.50, ch. 85.00 of Dy-22R/TSMC(S) including special repair of head regulator of M-2L/Dy-13R of TSMC(N) at Mouza Mohanpur and 10 (ten) other villages under Blocks Jhargram and Kharagpur-I within Districts of Jhargram and Paschim Medinipur respectively under Kangsabati Canals Division No. V.
2. The scheme under Sl (i) of Para 1 has been recommended by the “Directorate Level Technical Committee” in their 2nd meeting held on 23.07.2021 at an estimated cost of Rs. 175.76 lakh. The main structure of this irrigation scheme is severely distressed and needs immediate rehabilitation. The DPR has been framed by the Superintending Engineer, Western Circle-II based on the design and drawings prepared by the Central Design Office, Irrigation & Waterways Directorate and verified by the Directorate Level Technical Committee as stated earlier.
 3. However, the Departmental Screening Committee (DSC) recommended further economization of the project cost by way of deleting the item of cement concrete approach road construction contained in the DPR considering the fact that the item is not directly connected with the irrigation scheme. The revised scheme at an estimated cost of Rs. 149.50 lakh was recommended by the DSC.
 4. The 2nd scheme under Sl (ii) of Para 1 is related to rehabilitation of 6 no. of RCC bridges and 7 other distressed structures. Only one of the bridges has been placed before the Bridge Inspection Committee set up for evaluation of rehabilitation of bridges. Hence, it was directed by the DSC to place the remaining five bridges before the zonal committee of bridge inspection and obtain their recommendations for all the 6 bridges for consideration of the scheme in the next DSC meeting. Other minor corrections as suggested during the meeting by the Financial Advisor also need to be incorporated.
 5. Finally, only the scheme for “Renovation of head works structure of Tarkey Minor Irrigation scheme in Block Gopiballavpur-I, P.S Gopiballavpur, District Jhargram” under

Jhargram Flood Management & Planning Division at a modified estimated cost of Rs 149.50 lakh was cleared by the DSC for inclusion under Core State Development Schemes budget of I&WD under Demand No. 32, B.P no 18 during the current FY 2021-22.
