
**ORDER**

Employees) Rules,1980 read with No.1853-F(P) Dt.2.3.12 in favour of Sri Uttam Hazra, Executive Engineer, Contai Irrigation Division, Irrigation & Waterways Directorate , to acquire a plot of land 3.44 decimal, situated in R.S.
