Agenda: Proposal for recommendation of 11 (eleven) new schemes (02 schemes costing above Rs 1.50 crore) for inclusion under Core State Development Schemes (Voted) budget of Irrigation & Waterways Department during the current FY of 2021-22.

Secretary took the chair.


The following were discussed:

1. DPR of 6 no. of schemes, included in the list of 107 schemes selected in the Departmental Review Meeting taken by Hon'ble MIC on 13.07.2021, were initially placed in the

meeting. Five more schemes were discussed during the meeting under East Midnapore Division, Ganga Anti Erosion Division No. I and Malda Irrigation Division, I&W Dte.

2. The following schemes were directed for re-submission after necessary correction
 - (i) The scheme for renovation of 10 nos. moderately distressed bridges and 1 no. cross regulator gate over SMC and IMC in Khatra, Hirabandh and Indpur of Bankura District under K.C.Division-I, Khatra has to be resubmitted by omitting jacketing items.
 - (ii) The scheme for rehabilitation of distressed cart bridges over DNMC in Goalpokhore of Uttar Dinajpur District under Teesta Canal Division-II, Islampur has to be resubmitted with requisite suggestions of the Apex Committee of Bridge Inspection & Monitoring Units of this Department
3. Out of remaining 9 schemes, 2 nos. of schemes (Sl. 1 & 2) have been technically recommended by the Directorate Level Technical Committee in their 18th Meeting held on 24.12.2021, 2 nos. of schemes (Sl. 3 & 4) technically recommended by the Directorate Level Technical Committee in their 12th Meeting held on 18.11.2021, 1 no. of scheme (Sl. 5) technically recommended by the Directorate Level Technical Committee in their 5th Meeting held on 13.08.2021, 1 no. of scheme (Sl. 6) technically recommended by the Directorate Level Technical Committee in their 16th Meeting held on 16.12.2021 and the scheme under Sl8 being above Rs. 5 crore value have been technically recommended by the Departmental Technical Committee of Chief Engineers in their 285th meeting held on 13.12.2021.
4. The name of the scheme under Sl. 6 & 7 has been modified commensurate with the actual work.
5. As proposed by the Chief Engineer (North), I&W Dte, the restoration work on the right bank of river Ganga for a length of 550 m (from Ch. 14955 m to Ch. 15505m of downstream of Farakka Barrage) in ward No. 17 & 16 under Dhuliyān Municipality, PS-Samsanganj, District-Murshidabad at an estimated cost of Rs.973.97 lakh may be referred to the Urban Development & Municipal Affairs Department for funding so that the work may be taken up as deposit work since after implementation, this scheme would extend benefit towards Dhuliyān Municipality and adjoining areas. However Chief Engineer (North), I&W Dte, has been requested to submit a formal proposal for the same to this Department so that the matter may be referred to the concerned Department at the earliest

6. The scheme under Sl. 7 related to implementation of IT infrastructure in VVIP Bungalow at Malda amounting to Rs. 22.42 lakhs is cleared by the DLTC as well as recommended by the DSC for accordance of administrative approval and subsequently be referred to the PWD North Bengal IT Division for implementation of the work on deposit terms.
7. Finally, 08 nos. schemes as per Annexure have been cleared by the DSC for inclusion under Core State Development Schemes budget of I&WD under Demand No. 32, B.P no 18 during the current FY 2021-22. However, one of the scheme (under Sl. 8) needs to be submitted to the Finance Department for administrative approval and the remaining 7 (seven) schemes (Sl. 1 to 7) may be approved under delegated Departmental power for administrative approval, each costing within Rs. 1.5 crore.




