Agenda: Proposal for recommendation of 11 (eleven) new schemes (08 nos costing below Rs 1.50 crore)for inclusion under Core State Development Schemes(Voted)budget of Irrigation & Waterways Department during the current FY of 2021-22.

Secretary took the chair.

The following were discussed:

 DPR of 02 no. of schemes ( under sl 5, 6 ) included in the list of 107 schemes selected in the Departmental Review Meeting taken by Hon'ble MIC on 13.07.2021 were initially placed in the meeting. Nine ( 09) more schemes were discussed during the meeting under Metropolitan Drainage Division-II, EE-I, Canals Division , Contai Irrigation Division and West Midnapur Division of I&W Dte.

- 2. Out of 11 schemes, 01 scheme (under sl 5) technically recommended by the Directorate Level Technical Committee in their 8<sup>th</sup> Meeting held on 10.09.2022 placed in the DSC dated 01.11.21 but not resolved ,01 scheme ( under sl 6 ) technically recommended by the Directorate Level Technical Committee in their 6<sup>th</sup> Meeting held on 23.08.2021, placed in the DSC dated 01.09.21 but not resolved. 04 scheme ( under sl 7, 8, 9, 10 ) technically recommended by the Directorate Level Technical Committee In their 26<sup>th</sup> Meeting held on 15.02.2022. All of those 08 schemes have been placed in the DSC out of which 06 schemes (under sl 5,6,7,10) have been recommended by this DSC with some modifications in name of work.
- 3. One scheme ( under sl 11 ) under West Midnapur Division ,being above Rs. 5 crore value ,technically recommended by the Departmental Technical Committee of Chief Engineers in their 289<sup>th</sup> meeting held on 18.02.2022 . This present scheme of rehabilitation of damaged downstream floor of Midnapur Anicut has been examined by the DSC. The scheme has been recommended by the DSC for implementation with the condition that the instant work will be the Phase-I work of overall planning for rehabilitation. The Phase-II work will have to be planned, preferably with the help of a Model Analysis followed by design & drawing etc. in consultation with the Central Design Office, I&WDte. The planning activity of phase-II works is to be completed in next 06 months.
- 4. Two schemes under Metropolitan Drainage Division-II ,being above Rs. 5 crore values, technically recommended by the Departmental Technical Committee of Chief Engineers in their 282<sup>th</sup> meeting held on 07.10.2021 .These 02 schemes were earlier recommended by the DSC held on 18.11.21 although Administrative Approval has not yet accorded. Subsequently in the review meeting with the Urban Development & Municipal Affairs Department and Kolkata Municipal Corporation ,the urgency of immediate taking up of the reaches of said two drainage channels i.e. immediate upstream of new Chowbhaga Pumping Station were pointed out and emphasized. So it has been felt prudent to go for preparation of separate schemes on each drainage channels for timely completion. Accordingly ,the Chief Engineer (South) has submitted two schemes on each drainage channels by splitting the original two schemes and according revised technical sanction. In the above back drop, the present DSC recommended the implementation of said 04 schemes ( under sl 1, 2, 3, 4 ) after superseding the RoD of DSC dated 18.11.21 in this regard.

- Finally, 09 nos. schemes as per Annexure have been cleared by the DSC for inclusion under Core State Development Schemes budget of I&WD under Demand No. 32, B.P no 18 during the current FY 2021-22.
- It has been directed to submit the soft copy (PDF version) of all the schemes as per enclosed list duly technically sanctioned after incorporation of the minor changes as suggested in the DSC meeting.
