Agenda: Proposal for recommendation of 15 (fifteen) new schemes (10 nos. costing below Rs 1.50 crore) for inclusion under Core State Development Schemes(Voted)budget of Irrigation & Waterways Department during the current FY of 2021-22.

Secretary took the chair.

The following were discussed:

1. DPR of 04 no. of schemes (under sl 6,7, 9,10) included in the list of 107 schemes selected in the Departmental Review Meeting taken by Hon'ble MIC on 13.07.2021 were

initially placed in the meeting. Eleven (11) more schemes were discussed during the meeting under EE-II, Canals Division, Subarbun Drainage Division, Calcutta Drainage Outfall Division, Bankura Irrigation Division, Investigation & Planning Division(South), Metropolitan Drainage Mechanical Division, Mayurakshi South Canals Division, North Dinajpur Irrigation Division, EE-II, Lower Damodar Irrigation Division of I&W Dte.

- 2. Out of 15 schemes, 02 schemes (under sl 9, 10) technically recommended by the Directorate Level Technical Committee in their 8th Meeting held on 10.09.2022 placed in the DSC dated 01.11.21 but not resolved, All of those 2 schemes have been placed and recommended by this DSC with some modifications in name of works.
- 3. 05 schemes (under sl 2, 5, 6, 7, 8) technically recommended by the Directorate Level Technical Committee in their 27th Meeting held on 22.02.2022, 02 schemes (under sl 3, 11) technically recommended by the Directorate Level Technical Committee in their 28th Meeting held on 02.03.2022. 01 scheme (under sl 12,) technically recommended by the Directorate Level Technical Committee in their 29th Meeting held on 07.03.2022. All of those 07 schemes have been placed and recommended by this DSC with some modifications in name of works.
- 4. Two schemes (under sl 1,4) originally being estimated cost above Rs. 5 crore value ,technically recommended by the Departmental Technical Committee of Chief Engineers in their 287th meeting held on 20.01.2022 & 288th meeting held on 11.02.2022 respectively. Both the schemes have been placed and recommended by the present DSC with some modifications in scope of work under sl 1.
- 5. One scheme on Hooghly left embankment within block: Kulpi, Dist: 24 pgs (South) under EE-II, Canals Division technically recommended by the Directorate Level Technical Committee in their 8th Meeting held on 10.09.2022 placed in present the DSC and directed for resubmission through Directorate Level Technical Committee after obtaining observations of Central Design Office, I&W.Dte.
- 6. 01 scheme related to engagement of consultant for assessment and demarcation of flood prone areas in West Bengal under I.P.Division (South) technically recommended by the Directorate Level Technical Committee in their 27th Meeting held on 02.03.2022, placed in present DSC and resolved that this scheme will not come under preview of present DSC considering nature of work, however Administrative Approval against this scheme of the Department will be taken up separately considering urgency.

- 7. One scheme on right bank Hooghly within Serampore Municipality, Dist: Hooghly under EE-II, Lower Damodar Irrigation Division technically recommended by the Directorate Level Technical Committee in their 28th Meeting held on 2.03.2022 placed in present the DSC and directed for resubmission through Directorate Level Technical Committee after obtaining observations of Central Design Office, I&W.Dte.
- 8. Finally, 12 nos. schemes as per Annexure have been cleared by the DSC for inclusion under Core State Development Schemes budget of I&WD under Demand No. 32, B.P no 18 during the current FY 2021-22.
- 9. It has been directed to submit the soft copy (PDF version) of all the schemes as per enclosed list duly technically sanctioned after incorporation of the minor changes as suggested in the DSC meeting.
