Agenda: Proposal for recommendation of 11 (eleven) new schemes (10 no. schemes costing below Rs 1.50 crore) and one additional scheme for inclusion under Core State Development Schemes(Voted)budget of Irrigation & Waterways Department during the current FY of 2022-23.

Secretary took the chair. The following were discussed:

DPR of 01 no. of scheme (under sl 6) included in the list of 107 schemes selected in the Departmental Review Meeting taken by Hon'ble MIC on 13.07.2021 was initially placed in the meeting. Ten more schemes were discussed during the meeting under EE-II, Canals Division ,Mahananda Embankment Division, Metropolitan Electrical Division, Metropolitan Mechanical & Electrical Division, Metropolitan Drainage Mechanical Division ,Kangsabati Canals Division–V, East Midnapore Division, EE-II, Lower Damodar Irrigation Division of I&W.Directorate.

- 1. One scheme (under sl 1) on Hooghly left embankment within Block : Kulpi , Dist : 24 pgs (South) under EE-II, Canals Division technically recommended by the Directorate Level Technical Committee in their 8th Meeting held on 10.09.2021 placed in the DSC meeting held on 08.03.2022 and it was directed for resubmission of the scheme through Directorate Level Technical Committee after obtaining observations of Central Design Office, I&W.Dte. The scheme has been placed complying the direction of the DSC meeting held on 08.03.2022 and recommended by the present DSC with some modification in name of work .
- 2. 07 schemes (under sl 2, 3, 4, 5, 7, 8, 9) technically recommended by the Directorate Level Technical Committee in their 31th Meeting held on 29.03.2022, 01 scheme (under sl 6) technically recommended by the Directorate Level Technical Committee in their 30th Meeting held on 11.03.2022. All of those 08 schemes have been placed and recommended by this DSC with some modifications in name of works as well as some minor changes in scope of work.
- 3. One scheme (under sl 10) on right bank Hooghly within Serampore Municipality, Dist: Hooghly under EE-II, Lower Damodar Irrigation Division technically recommended by the Directorate Level Technical Committee in their 28th Meeting held on 02.03.2022 placed in the DSC meeting held on 08.03.2022 and it was directed for resubmission of the scheme through Directorate Level Technical Committee after obtaining observations of Central Design Office, I&W.Dte. The scheme afresh recommended by the Directorate Level Technical Committee in their 32th Meeting held on 07.04.2022. The scheme has been placed complying the direction of the DSC meeting held on 08.03.2022 and recommended by the present DSC.
- 4. 01 scheme related to re-excavation/de-siltation of Veragachi khal in Block & P.S. :Baruipur ,Dist: 24 Pgs (South) under Mograhat Drainage Division technically recommended by the Directorate Level Technical Committee in their 31th Meeting held on 29.03.2022. The scheme has been placed in present DSC. It has been decided that concerned Executive Engineer will carry out a soil sample test of the silt to be removed through RRI and send a proposal of de-siltation with the aforesaid soil test report to the Department. The same ,in turn, will be sent to WBMTDCL for carrying out the proposed de-siltation work.
- 5. 01 scheme related to operation & maintenance of drainage pumping stations at Khardah khal, Fatesha, Bongon sluices during the monsoon period 2022-23 under Metropolitan Mechanical & Electrical Division technically recommended by the Directorate Level

Technical Committee in their 31th Meeting held on 29.03.2022. The schemes has been placed in present DSC. It has been resolved that being such maintenance nature of work, the fund against this scheme amounting to Rs. 34.62 lakh is to be allocated out of available SDS maintenance budget for year 2022-23 of this Department.

- 6. Finally, 10 nos. schemes as per Annexure have been cleared by the DSC for inclusion under Core State Development Schemes budget of I&WD under Demand No. 32, B.P no 18 during the current FY 2022-23.
- 7. It has been directed to submit the soft copy (PDF version) of all the schemes as per enclosed list duly technically sanctioned after incorporation of the minor changes as suggested in the DSC meeting.
