Agenda: Proposal for recommendation of 15 (fifteen) new schemes (14 no. schemes costing below Rs 1.50 crore) and 05 additional scheme for inclusion under Core State Development Schemes(Voted)budget of Irrigation & Waterways Department during the current FY of **2022-23**.

Secretary took the chair. The following were discussed :

DPR of 05 no. of scheme (under sl 5,7,8,9,10) included in the list of 107 schemes selected in the Departmental Review Meeting taken by Hon`ble MIC on 13.07.2021 was initially placed in the meeting. Fifteen more schemes were discussed during the meeting under East Midnapore Division ,West Midnapur Division, Contai Irrigation Division, Kangsabati Canals Division–V, Asansol Irrigation Division,EE-I,Lower Damodar Construction Division, EE-I, Damodar Canals Division,Metropolitan Electrical Division, Metropolitan Mechanical & Electrical Division, Metropolitan Drainage Mechanical Division ,Berhampore Irrigation Division, Subarbun Drainage Division of I&W. Directorate.

1. Two schemes (under sl 1, 2,) on re-excavation of Mugdari khal under East Midnapur Division technically recommended by the Directorate Level Technical Committee in their 33th Meeting held on 19.04.2022 .Although work related to both the schemes are over same drainage channel, two separate schemes are framed in two separate stretches for urgent implementation of the works before ensuing monsoon as explained by concerned Chief Engineer. Both the schemes have been placed and recommended by this DSC with some modification in scope of work
2. One schemes (under sl 3,) on re-excavation of Machh Bhandar khal under West Midnapur Division technically recommended by the Directorate Level Technical Committee in their 33th Meeting held on 19.04.2022 . This scheme has been placed and recommended by this DSC with some modifications in name of work as well as some minor changes in scope of work.

For all those 03 schemes (under sl 1,2,3) “No Objection Certificate” from the appropriate authority of the District level regarding taking up the respective work by Irrigation & Waterways Department is to be obtained by the concerned Executive Engineer of the I.&W.Dte. as the drainage channels are beyond the territorial jurisdiction of this Department . Copy of the said NOC is to be attached with the respective scheme booklet [pdf copy] during final submission prior to processing for Administrative Approval of the same.


3. 02 schemes within block Potashpur-I along right embankment of river Keliaghai under Contai Irrigation Division technically recommended by the Directorate Level Technical Committee in their 26th Meeting held on 15.02.2022 ,placed in the present DSC meeting and it has been directed for resubmission of both schemes through Directorate Level Technical Committee after obtaining observations of Central Design Office, I&W.Dte.
4. 04 schemes (under sl 4, 15, 16, 17) technically recommended by the Directorate Level Technical Committee in their 33th Meeting held on 19.04.2022, 04 schemes (under sl 7, 12, 13, 14) technically recommended by the Directorate Level Technical Committee in their 32th Meeting held on 07.04.2022. 01 scheme (under sl 5) technically recommended by the Directorate Level Technical Committee in their 31th Meeting held on 29.03.2022. 01 scheme (under sl 18) technically recommended by the Directorate Level Technical Committee in their 29th Meeting held on 07.03.2022.All of those 10 schemes have been placed and recommended by this DSC with some modifications in name of works .
5. 02 schemes (under sl 8, 9) technically recommended by the Directorate Level Technical Committee in their 5th Meeting held on 13.08.2021 , placed in the DSC meeting held on

01.09.2021 but not resolved, 01 scheme (under sl 10) technically recommended by the Directorate Level Technical Committee in their 10th Meeting held on 05.10.2021 , placed in the DSC meeting held on 01.11.2021 but not resolved . All these 03 schemes have been placed in the present DSC meeting and recommended .

6. 01 scheme (under sl 6) under East Midnapur Division technically recommended by the Directorate Level Technical Committee in their 32th Meeting held on 07.04.2021 .The schemes has been placed in the present DSC meeting and recommended with some modification in scope of work.
7. 01 scheme (under sl 11) on Mahisdhara Khal within Dist : Howrah under EE-I, Lower Damodar Construction Division technically recommended by the Departmental Technical Committee of Chief Engineers held on 28.02.2022 . The scheme has been prepared in compliance to the judgment passed by the Hon'ble High Court at Calcutta in its verdict dated 14.12.2018 in connection with Writ petition no. 22948(W) of 2018 .The Scheme has been placed in the present DSC meeting and recommended with some modifications in name of work as well as some changes in scope of work.

It appears that a part of land is to be purchased directly near outfall of this khal at Howrah drainage channel in connection with execution of the work. It has been directed to submit the proposal for direct purchase of land to this department through the Chief Engineer (West),I&W.Directorates in terms of Memorandum No. 1703-LP/1A-03/14(Pt-II), dated 26.07.2021 of Department of Land & Land Reforms and Refugee Relif & Rehabilitation , GoWB. After obtaining concurrence of the Department of Land & Land Reforms and Refugee Relif & Rehabilitation for direct purchase of the land , Administrative Approval of the scheme will be processed

8. Finally, 18 nos. schemes as per Annexure have been cleared by the DSC for inclusion under Core State Development Schemes budget of I&WD under Demand No. 32, B.P no 18 during the current FY 2022-23.
9. It has been directed to submit the soft copy (PDF version) of all the schemes as per enclosed list duly technically sanctioned after incorporation of the minor changes as suggested in the DSC meeting.




