Secretary took the chair. The following were discussed :


DPR of 02 no. of schemes under Subarban Drainage Division included in the list of 107 schemes selected in the Departmental Review Meeting taken by Hon’ble MIC on 13.07.2021 was initially placed in the meeting. Eighteen more schemes were discussed during the meeting under Mayurakshi South Canals Division, North Dinajpur Irrigation Division, Urban Drainage Division, Mograhat Drainage Division, Metropolitan Drainage Division ,KKB Project Division, West Midnapore Division, Contai Irrigation Division of I&W. Directorate,

1. One scheme (under sl 1) technically recommended by the Directorate Level Technical Committee in their 34th Meeting held on 29.04.2022 , 01 scheme (under sl 2) technically recommended by the Directorate Level Technical Committee in their 35th Meeting held on 12.05.2022 All those 02 schemes have been placed and recommended by this DSC with some minor modification in name of work.
2. One scheme (under sl 4) technically recommended by the Directorate Level Technical Committee in their 34th Meeting held on 29.04.2022 , 01 scheme (under sl 3) technically recommended by the Directorate Level Technical Committee in their 35th Meeting held on 12.05.2022 All those 02 schemes have been placed and recommended by this DSC with some minor modification in name of work.
3. One scheme (under sl 5) technically recommended by the Directorate Level Technical Committee in their 11th Meeting held on 07.10.2021 .The scheme has been placed and recommended by this DSC with some minor modification in scope of work & name of work..
4. Six schemes (under sl 6 , 7, 8, 9, 10, 11) technically recommended by the Directorate Level Technical Committee in their 34th Meeting held on 29.04.2022 , Seven schemes (under sl 12 , 13, 14, 15, 16, 17,18) technically recommended by the Directorate Level Technical Committee in their 35th Meeting held on 12.05.2022. All those thirteen schemes have been placed and recommended by this DSC with some minor modification in name of work as well as scope of work.
5. One scheme under Mograhat Drainage Division related to special repair of road on Peali river embankment in P.S. : Jaynagar , Dist : South 24 parganas technically recommended by the Directorate Level Technical Committee in their 35th Meeting held on 12.05.2022 .This scheme has been placed and decided to be placed in next DSC .
6. One scheme under Suburbun Drainage Division related to protection of banks of Alampur main khal, Bahirchara branch khal in P.S : Nodakhali, Dist : South 24 pgs technically recommended by the Directorate Level Technical Committee in their 8th Meeting held on 10.09.2021 .This scheme has been placed and decided to be resubmitted in next DSC with some rectifications as discussed.

7. Two additional schemes under Cooch Behar Irrigation Division related to protection of bank/ embankment of River Torsha in P.S. : Pundibari , Dist : Cooch Behar technically recommended by the Directorate Level Technical Committee in their 36th Meeting held on 17.05.2022 .These 02 schemes have been placed and it was directed for resubmission of the scheme through Directorate Level Technical Committee after obtaining observations of Central Design Office, I&W.Dte.

Finally, 18 nos. schemes as per Annexure have been cleared by the DSC for inclusion under Core State Development Schemes budget of I&WD under Demand No. 32, B.P No 18 during the current FY 2022-23.

It has been directed to submit the soft copy (PDF version) of all the schemes as per enclosed list duly technically sanctioned after incorporation of the minor changes as suggested in the DSC meeting.
