Agenda: Proposal for recommendation of 03 (eleven) new schemes (03 no. schemes costing above Rs 1.50 crore) for inclusion under Special Central Assistance for FY of 2022-23.

Secretary took the chair. The following were discussed;

03 schemes were discussed during the meeting under Kangsabati Canals Division No. –V ,Jhargram Flood Management and Planning Division ,West Midnapore Division and Mechanical & Electrical Division , Midnapore of I&W.Directorate.

1. One scheme (under sl 1) related to bank protection work along right bank of river Subarnarekha at Tikaitpur & Parasia in P.S.: Gopiballavpur, Dist: Jhargram under Jhargram Flood Management and Planning Division initially technically recommended by the Departmental Committee of Chief Engineers in their 29^{7th} Meeting held on 06.06.2022. The schemes has been placed in the DSC meeting held on 1^{6th} June 2022 and it has been resolved that the scheme is to be reframed in consultation with the Central Design Office, I&W.Dte and to be resubmitted in forthcoming DSC meeting after due recommendation by the Departmental Committee of Chief Engineers.

In compliance the scheme has been reframed in consultation with the Central Design Office, I&W.Dte, technically recommended by the Departmental Committee of Chief Engineers in their 299th Meeting held on 26.07.2022. Now the schemes has been placed and recommended by the present DSC meeting with some minor modification in name of work and attachment of documents in said schemes

2. One scheme (under sl 2) related to construction of one 10 vent sluice structure over Tamillya khal, at Mansuka in P.S: Ghatal, Dist: Paschim Midnapore under West Dinapur Division technically recommended by the Departmental Committee of Chief Engineers in their 297th Meeting held on 06.06.2022. The schemes has been placed in the DSC meeting held on 16th June 2022 and it has been resolved that the scheme is to be reframed & resubmitted in next DSC meeting considering proper gates & hoisting arrangement system in consultation with the Chief Engineer (Mechanical & Electrical), I&W.Dte. with attachment of some additional documents in scheme booklet and to be resubmitted in forthcoming DSC meeting after due recommendation by the Departmental Committee of Chief Engineers.

In compliance this scheme has been reframed in consultation with the Chief Engineer (Mechanical & Electrical) ,I&W.Dte technically recommended by the Departmental Committee of Chief Engineers in their 299th Meeting held on 26.07.2022. Now the schemes has been placed and recommended by the present DSC meeting with some minor modification in name of work and attachment of documents in said schemes

It has been resolved that for this instant scheme separate tenders are to be invited by the "Civil Wing" as well as "Mechanical Wing" of Irrigation & Waterways Directorate having territorial jurisdiction, based on individual technically sanctioned amount within the provision of this scheme, for the interest of work.

- 3. One scheme on improvement of Tarafeni South Main Canal under Kangsabati Reservoir Project located within block: Jhargram ,Dist: Jhargram under Kangsabati Canals Division No.–V technically recommended by the Departmental Committee of Chief Engineers in their 299th Meeting held on 26.07.2022. The scheme has been placed in present DSC meeting. It has been resolved that the scheme is to be reviewed by the Chief Engineer (South-West) and to be resubmitted in next DSC meeting.
- 4. Finally, 02 nos. schemes as per Annexure have been cleared by the DSC for inclusion under Special Central Assistance during the current FY 2022-2023.
- 5. It has been directed to submit the soft copy (PDF version) of all the schemes as per enclosed list duly technically sanctioned after incorporation of the minor changes as suggested in the DSC meeting.
